I. Sojourner Truth Community Center Updates

D'Ana Smith

- **Newsletter Highlights:** Please take a look at our newsletter. A major highlight is our Holiday Youth Camp, which will help to keep the kids busy during the holiday vacation. There is a \$50 registration fee, but do not let this discourage you from applying. There is some funding available for folks who cannot afford the \$50, especially for former Lafitte residents.
- **Drum Circle:** We have worked with the Tulane Community Health Center to put on evening drum circles. These are a really great way to have some fun, learn about drumming and, maybe most importantly, work out stress at the end of the day.
- **Community Center Holiday Schedule:** Sojourner Truth will be closed for Christmas Eve, Christmas day and the weekend following Christmas day. The Center will also be closed New Year's Eve and New Year's Day.
- **Comment:** Miss Paul reflected how there used to be a regular drum circle in Galvez court and how great it would be to get the drum circle going again.

II. Lafitte Redevelopment Update

- Glad to be back after missing last month's meeting, while I was on vacation.
- **Re-occupancy:** We haven't forgotten about re-occupancy. We are currently taking the feedback we heard from residents at the meeting two months ago and from the resident's council to draft a clear set of guidelines for re-occupancy. We will be sure to bring that draft to a resident's meeting and go over it before finalizing anything.
- **Oral History Project:** As many of you may remember, we have been working to get an oral history project commissioned to celebrate the people and history of Lafitte. We have worked with Miss Paul and Miss Johnson from the Residents Council on a scope of work for a university or consultant team to do the work. As we select a partner, we are being careful to make sure that they understand how important it is to get the input and feedback of residents throughout the process. We will be sure to give updates.
- **Construction:** You can probably tell from the equipment outside that construction is moving along. No other major updates.

III. Phyllis Wheatley School

- I'm sure many of you remember that work that many residents and community members did to make building a new school in the neighborhood a high priority.
